Course Instructor

Dr. Paul T. Levin has an M.A. in political science with a specialization in comparative politics and a Ph.D. in international relations with a focus on the European Union enlargement, both from the University of Southern California (USC) in Los Angeles. As a Ph.D. candidate at USC he taught courses there for five years and is currently teaching at Stockholm University and Södertörn University College. His research interests include the European Union and the emergence of the modern nation-state.

Guest Speakers

Dr. Roland Almqvist is a researcher at the Institute of Local Government Economics, Stockholm University School of Business, Sweden. His research examines management control aspects in public organisations with focus on outcomes of New Public Management. He also teaches accounting and management accounting.

Dr. Göran Beckius is the former Director of Studies at Stockholm University's School of

Business and has many years of experience teaching and publishing on the topic of business ethics. He is also an elected representative in the Stockholm County Council.

- Dr. Monica Bjerlöv is an expert in organizational development at the consulting firm Arbetstagarkonsult. She was formerly a senior researcher at the National Institute for Working Life in Stockholm.
- Mrs. Kerstin Eliasson works at the Ministry of Education and Research and was formerly State Secretary for Minister of Education Leif Pagrotsky.
- Dr. Tony Fang is Associate Professor of Business Administration at School of Business Stockholm University (SU). He is also Visiting Associate Professor at Asia Research Centre, Copenhagen Business School (CBS). Tony Fang holds his Ph.D. in International Management/Industrial Marketing from Linköping Institute of Technology (LiTH), Sweden. He earlier worked as Assistant Professor and Director of International Graduate Program in the Institute of International Business, Stockholm School of Economics (SSE). Tony Fang has been a visiting scholar in a number of institutions of higher learning including the Political Science Department, Massachusetts Institute of Technology (MIT, host professor Lucian W. Pye).
- Dr. Otto Granberg, an expert on leadership and organizational transformations, is a researcher at the Department of Education at Stockholm University and a consultant.
- Mrs. Anna Hedborg holds a degree in economics. Following an earlier career within the Swedish Confederation of Labor, she held a number of top-ranking positions in government and public administration. She was one of two Social Democratic Party representatives in the Pension Working Group, which created the Swedish pension reform. The legislation was passed in the late spring of 1994, and with a change of government in the autumn of 1994, Hedborg became Deputy Minister in charge of Social Insurance. In this capacity, she initiated and chaired the Implementation Group for the reform. In 1996, she became Director General of the National Social Insurance Board (called the State Social Insurance Agency as of 2005), which was responsible for the practical implementation of the reform. In 2005, she left her position at the National Social Insurance Board to become the Government's special investigator on the Future of Social Insurance.
- Mr. Peter Honeth is State Secretary at the Ministry of Education and Research. He was formerly Director of Lund University.
- Dr. Annika Lagerqvist Veloz Roca is a Docent and Doctor of Laws and Associate Professor in Public Law at the Stockholm University Departement of Law, Juridicum. She teaches constitutional law, law of public administration, and migration law.

Mr. Paul Lindquist is mayor and chairman of the Municipal Executive Board in Lidingö since

2003. He's been a deputy member of the municipal council between 1985-91 and a member between 1991-1997 and since 2002. Lindquist has also been the chairman of the Public Works Committee (1989-94) and the Child Care Committee (1995-97). Upon graduation from Uppsala University in 1989 with a BSc in Economics, Lindquist worked for IBM in various sales and marketing positions. In 1993 he joined telecom giant Ericsson as product manager. 1997-1999 he worked for Ericsson in California. 1999 he returned to Sweden as Program Manager for Ericsson Mobile Communications (presently SonyEricsson) and 2001 he was appointed head of Product Management for Customer Support at Ericsson AB.

- Dr. Ulla Pettersson is Professor Emeritus of Social Work at the Department of Social Work, Stockholm University. She teaches and publishes on social work, ethics, and the intellectual history of social work. She is currently working on a book about the reform of the Swedish social services laws.
- Dr. Daniel Tarschys is a Professor and the Prefect of the Department of Political Science at Stockholm University. Among his many chairmanships, he is currently the Chairman of the Swedish National Council on Medical Ethics and of the Swedish Institute for Growth Policy Studies. His previous positions include those of Secretary General of the Council of Europe and Member of Parliament for the Liberal Party (FP).
- Mr. Per Tengblad, MBA, Stockholm School of Economics, is a labour consultant and researcher at ATK Arbetstagarkonsultation AB and was formerly a union official at the Swedish Confederation for Salaried Employees. He has done consulting work for local unions and management mainly in the public sector and carried out training programmes for unions. He has participated in research on co-determination, ICTdevelopment, learning, restructuring and European Works Councils and has as published work on change processes, participation, learning, redeployment and EWC.
- Dr. Per Thullberg is the Director General of the Swedish National Agency for Education. He was formerly Chancellor of Södertörn University College.
- Dr. Sven Trygged is a Senior lecturer at the Department of Social Work at Stockholm University. He teaches social policy, social work and research methods, and has published on the social services in Sweden and elsewhere. Dr. Trygged's current research focuses on socioeconomic consequences related to stroke and on support to vulnerable families and children in Russia.
- Mrs. Marianne von der Esch holds a Master of Laws degree from Stockholm University. She is currently the International Coordinating Director at the Swedish Parliamentary Ombudsmen and has carried out missions in this capacity in Vietnam, Albania, Kyrgyzstan, Georgia, Poland, Romania, Burkina Faso, Armenia, Macedonia, Egypt, Jordan, China, Mongolia and Russia.

Dr. Björn von Sydow is a Docent in political science and Member of Parliament for the Social

Democratic Party (SAP). His was previously Minister of Defence and Minister of Trade, and until last year he was the Speaker of the Parliament.
