Doctoral Dissertation, 3 June 2002. – About processes of 'informalization' in Guinea-Bissau, studying both the informal income-generating activities and the social networks that urbanites engage in to sustain their incomes and consumption. 10. **Andersson, Agnes:** *The Bright Lights Grow Fainter: Livelihoods, Migration and a Small Town in Zimbabwe*. Doctoral dissertation, 7 June 2002. – A case study on Rusape in Zimbabwe, about how the individual migrant uses mobility to negotiate the economic landscape. This involves mobility directed *towards* small towns to access advantageous provisioning possibilities as well as engaging in several family linkages *from* the small town to other places within the settlement system. 11. **Liwenga, Emma T:** *Food Insecurity and Coping Strategies in Semiarid Areas: The Case of Mvumi in Central Tanzania*. Doctoral dissertation, 21 March 2003. – How can the food crisis in African drylands be challenged? This study examines the potential of dryland food resources from an historical perspective and with a focus on local knowledge, taking into

account socio-economic differences among households. The study shows that the capacity of the household to mobilize labour is crucial for the ability to control seasonality. This capacity differs for different wealth groups. ISBN 91-22-02009-8. 186 pp.

- 12. Börjeson, Lowe:** *A History under Siege: Intensive Agriculture in the Mbulu Highlands, Tanzania, 19<sup>th</sup> Century to the Present*. Doctoral dissertation, 17 September 2004. – Examines the history of agricultural intensification in the Mbulu Highlands of northern Tanzania. The study concludes that the process of agricultural intensification has largely been *its own driving force*, based on self-reinforcing processes of change. - 13. Byerley, Andrew:** *Becoming Jinja: The Production of Space and Making of Place in an African Industrial Town*. Doctoral dissertation, 19 September 2005. – Drawing from theories of Michel Foucault, Gilles Deleuze and Felix Guattari as well as archival studies and ethnographic fieldwork, the colonial production of space and the making and becoming of place are examined through a historical and spatial analysis of the Walukuba ‘African’ Housing Estate, built between 1949 and the mid-1950s. This estate was a key disciplinary space in the transition from the pre-W.W.II sovereign diagram of power to a more disciplinary and bio-political diagram in the post-W.W.II era. - 14. Cadstedt, Jenny:** *Influence and Invisibility: Tenants in Housing Provision in Mwanza City, Tanzania*. Doctoral dissertation, 8 June 2006. – Large proportions of urban dwellers in African cities rent rooms from private landlords. Governmental housing policies, however, focus on house owners. This dissertation deals with this discrepancy between policy and practice in Tanzania and discusses possible consequences, such as lack of local participation and feelings of citizenship among dwellers. - 15. Kjellén, Marianne:** *From Public Pipes to Private Hands: Water Access and Distribution in Dar es Salaam, Tanzania*. Doctoral dissertation, 22 September 2006. – While privatization involving international water companies hits the news headlines, more discreet forms of privatization already exist at the local level. This work explores the intricate roles of public and private actors in the water system in Dar es Salaam. It examines the formal private sector participation in utility operations, the informal water vending, as well as the *spaghetization* of the piped distribution network. ISBN 91-85445-43-6. 329 pp.
