Below I have listed the topics discussed and the 'end recommendation' from the group.

1. Should we have 'age' or employment limits for supervisors?

The end suggestion is that we do <u>not</u> put up any formal rules, since we felt that it is better that the 'de facto' supervisor is also listed as the main supervisor. However, to make the more extended role of the 2nd supervisor when it comes to all retired main supervisors, they should from now on participate in the 'antagningssamtal'.

2. Should we limit the number of Ph D students each Pl can get co-sponsored by DBB?

We feel we have and want to keep a generous system, BUT that it does involve a substantial co-financing of PIs with many students. We ended in a suggestion that we do want a limit and that this limit should be 4 simultaneously DBB-sponsored Ph D students for one and the same supervisor. Maria agreed that it is not too much administrative work to check this. This would then be in effect for Ph D students accepted after we make the decision.

3. Dissertations; how to get better attendance?

The root to this discussion is that we feel that dissertations at DBB are very poorly attended. We have two linked suggestions here. First, Pia will add an appendix to the 'yearly evaluation' that asks all Ph D students to list the seminars and dissertations they attended so that its made more clear that we do require a good attendance. Secondly, we suggest to make a short (5 min) break after the introduction and summary at the dissertations. This will facilitate for people to attend this part only without disrupting the procedure, since we feel it is better that we get attendance for this part than that people do not come at all. To clarify, the mentioned list above will have 'Dissertations intro' and 'dissertations, full' separated so that we make it clear that Ph D students should still attend the full ceremony as well.
