# Introduction

During 2022 the Institute continued to work in line with the aims of its statute, from 2019. One of the points mentioned in the statute is to conduct research and outreach activities in collaboration with Swedish and other Nordic Universities. NILAS' Directive Board, with members from Nordic countries, has explored venues for cooperation and for attracting external funding. An important achievement in this direction was the starting of activities connected to the project "New Approaches and Synergies in Nordic Latin-American Studies: Applying Area Studies in a Multipolar World," funded by the Joint Committee for Nordic Research Councils in the Humanities and Social Sciences (NOS-HS). Two international workshops were organized within this project's framework: "Geopolitics, climate change and the search for justice: The prospects for energy cooperation between Nordic and Latin American countries" (May 9, at the Centre for Development and the Environment, University of Oslo) and "Facing the Challenges of Climate Change – Latin American Perspectives" (November 17-18, at the Nordic Institute of Latin American Studies, Stockholm University).

As part of our initiative to approach environmental issues, NILAS hosted and organized another international workshop on November 14-15: "Archives of the Planetary Mine: Culture, Nature Extraction, and Energy Across the Americas." The workshop was organized by Gianfranco Selgas (University College London/NILAS, Stockholm University); Henrik Ernstson (KTH/The University of Manchester) and Thaïs Machado Borges and Ariel Sribman Mittelman (both from NILAS, Stockholm University) with funding from <u>Riksbankens jubileumsfond's starting grant</u> supporting humanities and social sciences, and with funds from KTH Dept of Environmental Science (aka SEED) and its project "<u>The Situated Ecologies Platform, art, design and research collaborations to contest and democratize ecologies</u>."

The Institute continues improving its work with education, research and outreach activities. The Annual Report 2022 provides a compilation of all the activities carried out in the past year.

# Research

Research on Latin America and the Caribbean at the Nordic Institute of Latin American Studies is an interdisciplinary enterprise with a social scientific thrust. NILAS" staff publishes and presents research results for academic and non-academic audiences. The Institute's continuous work with its peer-reviewed, open access journal, *Iberoamericana - Nordic Journal of Latin American and Caribbean Studies* should be highlighted. In 2022, 9 original pieces of research were published, along with 3 book reviews.

The Institute's research seminars took place throughout the year, featuring invited national and international scholars, reflecting the richness and breadth of the Institute's multiple networks. Research seminars provide a forum for researchers from different disciplines with various theoretical interests who are engaged in conducting empirical research on Latin America.

In what follows, we present our research-related activities during 2022.

## **Research projects**

#### Thaïs Machado-Borges

Project title: "Gender Troubled? Culture Wars on Sexuality, Gender, Religion, and Politics in Contemporary Brazil"

#### Project period: 2019-2022

Summary: Part of the 2030 Agenda for Sustainable Development Goals, gender equality and sexual and reproductive rights have become the stuff of heated controversies in contemporary Brazil, producing new frontlines of struggle in a society marked by internal divides. How are ideas circulated and reinterpreted as they transit through geographic and sociopolitical contexts? Are certain concepts a foreign, top-down intrusion on national matters, or are they a means to lessen inequalities? This project tracks how the concept of gender used in expressions such as gender ideology and gender equality flows through different arenas of the Brazilian society, mobilizing publics towards various forms of collective action. The project, to be conducted during three years by a team of researchers, is divided into three questions: how are these concepts used in political decisions and debates? How are they configured in sayings, words, and images spread through public spaces? How are they discussed by feminist, conservative, and religious activists? Data will be gathered in Southeastern Brazil, using methods such as discourse analysis, field observations, focus groups, and interviews.

#### Andrés Rivarola Puntigliano

Project title: The ups and downs of Latin American regionalism

Project leader: Andrés Rivarola (NILAS) and José Briceño Ruiz (at UNAM, Mexico)

Summary: Crisis seems to be a permanent situation of the Latin American regionalism. Proposals such as LAFTA and the Andean Pact in the 1960s and 1970s, Mercosur in the 1990s or UNASUR in the 2000s have

shown a similar pattern. They were initially a success in terms of trade exchanges and led to increasing political cooperation (like in the case of UNASUR). After initial achievements, those processes entered a period of stagnation and later crisis. We are currently in one of these moments of crisis, with the elimination of UNASUR and the paralysis of Mercosur and the Andean Community. A main question for this symposium is what are the reasons that explain the patterns of decline and crisis in Latin American regional schemes? Are there specific issues for each integration project, or are there common elements that might explain failures? The aim of is to analyze issues such as, the reasons behind the failures of the Latin American regional initiatives. We explore issues such as the lack of regional leadership, weak institutional frames of the integration schemes, limited participation of social actors, and the lack of consensus about the economic model to be followed at regional level.

Summary: The research project «Happiness in History: from Rome to our days. Discourse Analysis (FELHIS)» intends to develop and disseminate a corpus of texts that deal with the issue of happiness, from its multiple perspectives, in ancient historiography. At the same time, it is dedicated to analyzing the tradition and reception of these classic ideas in contemporary literature, mainly Hispanic, both fiction and other genres.

We give a dual meaning to the three key concepts of our project: happiness (public / private); history (as the historiographical genre / as the succession of human events); speech (oratory piece / text or message). Managing the broad and strict sense of the concept of happiness will allow us to offer more useful approaches. The FELHIS project is funded by the BBVA Foundation and the Spanish Society for Classical Studies (SEEC) within the Logos Program for Research Grants in the Area of Classical Studies. It is developed within the scope of the Institute of Medieval, Renaissance and Digital Humanities Studies (IEMYRhd) of the University of Salamanca.

#### Latin American Studies I (30 credits)

Teachers	Magnus Lembke, Ariel Sribman
Content	The course gives an introduction to the historical background of contemporary social conditions in Latin America. It deals with the colonial time, the first period of independency and the 20th century. It focuses on how social structures (class, ethnicity, gender) have originated and changed over time, how the idea of citizenship has been formulated and how it is implemented, the organization of economic production as well as the changing role of the state. The course is divided into the following parts which can also be studied as autonomous courses:

#### Latin American Studies II (30 credits)

Teachers	Gianfranco Selgas, Ariel Sribman
Content	The aim of the course is to give a deeper knowledge of four broad topics whose basic configurations have been formed historically and which have been treated chronologically in the basic course: culture, social conditions, economy, and politics. The course is divided into the following parts of which part 3 can also be studied as an autonomous course.

#### Latin American Studies, Bachelor's course (30credits)

Teachers	Magnus Lembke, Ariel Sribman and dissertation supervisors
Content	The course consists of one part which focuses on interdisciplinary theory and methodology (7.5 credits), including both qualitative and quantitative methodological approaches. This part gives in-depth knowledge of how to write a scientific exam paper. Another part of the course focuses on thematic and regional specialization (7.5 credits). This part discusses and compares different Latin American sub-regions. In the third part of the course, the student carries out a limited research task which is presented in the candidate exam paper (15 credits).

#### Latin American Studies, Master Program (120 credits)

Content	The program is interdisciplinary and provides in-depth knowledge of Latin America's economic social, legal and political conditions from a perspective that emphasizes the importance of knowledge of the history, language and culture for understanding the social processes. The Program highlights the importance of understanding the region based on its interaction with the rest of the world. In addition to the study of Latin America as a whole the opportunity will be given to focus on individual themes and geographical areas of the continent on the basis of their specific dynamics. Social and cultural theories are studied and applied on cases from region. The relationship between area studies and interdisciplinary studies is especially emphasized in the theoretical and methodological module. An opportunity to conduct one semester of internship ir Latin American is also offered. The final paper provides an opportunity for emphasizing thematic and regional issues.

	During 2021 the following courses were offered, apart from individual tutoring:			
	Democratization in Latin America: Citizenship, Institutions and Rule of Law, 7,5 credits Teacher: Magnus Lembke			
	The course departs from the notion that Latin America, during the 20th century, experienced two waves of democratization. A main theme of study are the reasons as to why different countries took alternative roads to democracy. The main focus here is dedicated to those processes of			
	democratization which were initiated in the late 1970s and 1980s, as well as a number of deficiencies in these processes with regards to the institutional structure of the state and the			

defense of citizenship rights. Moreover, the course discusses innovative reforms enacted recently in various countries in order to create and strengthen local forms of participatory democracy.

#### Gender and Post-Colonialism in Latin America, 7,5 credits Teacher: Thaïs Machado-Borges

The course highlights the impact of post-colonial thinking on contemporary Latin America research, focusing for example on theories developed within the framework of the so-called race-class-gender matrix. The course presents and discusses issues such as Latin American theorizing on gender, a perspective aiming at grasping the complexity of contemporary and historically rooted structures of inequality. The course also enters into more specific themes: violence against women, sexual and reproductive health and rights, feminist activism, social constructions of masculinity and LGBT+ perspectives.

#### Latin American Studies, Theory and Methodology, 7,5 credits Teacher: Magnus Lembke

The module gives a deepened knowledge in theoretical and thematic lines within the area of Latin American Studies. In addition, the course presents and examines the interdisciplinary perspective and the theoretical and methodological approaches within some of the social science research perspectives.

#### Latin American Social History, 7,5 credits Teacher: Magnus Lembke

The course focuses on how different strategically important social groups have been developed and inserted into Latin American society, such as the military, the Church, the landed elite, the business community, women, labor and peasants etc. It analyses the constellation and stratification of social forces at different historical junctures as well as historically changing power relations within these groups. The course puts emphasis on the formation of modern Latin American society since the 1930s onwards.

## Latin American Thinking: Socio-Economic, Political and Cultural Ideas, 7,5 credits Teachers: Ariel Sribman

The history of ideas in Latin America is related to the power structures which have characterized the region since the encounter between the European and indigenous civilizations. The course focuses on the ideas and theories attempting to explain this basic and difficult coexistence between different social groups within a societal hierarchy marked by immense inequalities in terms of class, race, ethnicity and gender, as well as the also conflictive relationship between the continent and the international powers. The course takes up some of the main contributions of Latin American thinkers in areas such as politics, sociology, economy and pedagogy, as well as the local adaptations of imported ideas in these areas. The aim of the course is to provide an understanding of the ideas which have historically prevailed in Latin America as well as of the social, economic and political context which have nurtured them.

#### Geography, Regions and People in Latin America, 7,5 credits Teacher: Thaïs Machado Borges

Latin America is a vast region spanning parts of North America, the West Indies and most of Central and South America. The course focuses on understanding the geography of Latin America and its sub-regions, such as the Andean countries, the Southern Cone, the Caribbean and Central America, including Mexico. The course does also analyze the cultural and national features behind the conformation of the region, its sub-regions and its respective nation-states. All this is connected to the economic and geopolitical elements which have impacted on the developments of these geographical spaces. The aim of the course is to deepen the knowledge of how regions, peoples and landscapes take shape and how they change.

#### Latin America in a Global World, 7,5 credits Teacher: Andrés Rivarola

The course aims to provide increased understanding of Latin America and its history, politics, finances and culture from a global perspective. This refers to an understanding of how links to other parts of the world have influenced Latin America, as well as how the region has influenced

other parts of the world. The course applies a historical perspective, focusing on analyses of transnational networks and creation of international systems in the post-colonial age. It addresses the emergence and changes of global relationships, and how this has impacted local conditions in Latin America. The course gives the students an understanding of continuity and change, and how trade and goods have influenced society, state building and cultures. Central elements of the course include links between the past and the present, in addition to relationships between the local and the international.

## Development and Sustainability in Latin America and the Caribbean, 7,5 credits Teacher: Ariel Sribman

Once more, Latin America has strengthened its position as an exporter of raw materials following international rules. Certain researchers believe that this – in combination with globalisation and increasing international competition for natural resources – will limit the possibilities to guarantee sustainable development. They emphasise that increased orientation towards mining operations and mono-cultural agriculture will have a detrimental impact on the environment and social relationships caused in part by a marginalisation of small-scale agriculture, deforestation, demographic changes and new migration movements. Other researchers believe that this development generates growth and international competitive powers, thus freeing up resources for social reformation programmes. This course analyses these two standpoints, in addition to state and social actors whose activities address matters of sustainable development. Furthermore, the course discusses how on the one hand, sustainable develop relates to democracy, and social justice on the other hand. Such a discussion requires a fundamental review of definitions and notions of "development", and how these differences have influenced Latin American politics and public debate.

## Iberoamericana

The journal has developed in 2022 and the Editorial Team will continue working on long-term strategies to get the journal listed in databases, which will increase the impact of the publications. *Iberoamericana* is now registered in the Scopus and the Redalyc databases. *Iberoamericana* accepts articles in English, Spanish, and Portuguese.

In 2022 *Iberoamericana* published 9 original research articles and 3 book reviews. It received in total 34 submission during the year, which means an increase of 70% compared to 2021. The total number of submissions includes 28 research articles, 3 review article and 3 book reviews. The acceptance rate was 43%. The submissions came from all over the world, including Colombia (6), Argentina (5), Spain (4), Sweden (3), United States (3), Chile (2), China (1), Costa Rica (1), Denmark (1), Ecuador (1), France (1), Hungary (1), Italy (1), Mexico (1), Poland (1), United Kingdom (1) and Venezuela (1). The number of web page views raised in a 0.08%. During 2021 there were 55,626 page-views (cp. 2021: 55,582; 2020: 44,390; 2019: 27,655) and 33,430 users (cp. 2021: 35,588; 2020: 27,529; 2019: 12,516) users mostly from Argentina (14.91%), followed by the United States (13.99%) and Mexico (13.41%).

*Iberoamericana* continues to provide a high-quality peer-review and dissemination platform without any charges for authors. The Institute of Latin American Studies at Stockholm University will, therefore, continue to cover the costs of open access publication, topping up a generous grant from the Joint Committee for Nordic Research Councils in the Humanities and Social Sciences.

# Library

The Library of the Institute of Latin American Studies specialises in documentation on Latin American and Caribbean social, political and economic development. This extensive collection of social scientific literature on Latin America and the Caribbean is one of the biggest in Scandinavia. The Library houses approximately 50,000 books, in addition to a wide range of scientific periodicals, news bulletins and reports from various research centres in USA, Europe, Latin America and the Caribbean. It also holds a collection of Latin American fiction.

In collaboration with the Stockholm University Library, the Institute's Library also has a large number of databases and electronic journals. Among the databases, the HAPI-Online is of particular interest. This database contains bibliographical citations to articles, book reviews, documents and other materials appearing in more than 500 key social science and humanities journals published throughout the world. The database Latin American Intelligence Service is another valuable resource. The Library is affiliated to REDIAL (*Red Europea de Información y Documentación sobre América Latina*), a network of European libraries specializing in Latin America. The webpage of REDIAL offers access to several European databases on Latin American information and investigation. European dissertations, including Swedish ones, on Latin America can be searched in the REDIAL Thesis database.

During 2022 new acquisitions to the library amounted to around 221 volumes. The Library is open to students, researchers and the public. The online catalogue can be accessed at Stockholm University Library's web page: http://su.se/biblioteket/. The titles are also entered in the union catalogue for the Swedish university libraries, LIBRIS: http://www.libris.kb.se. Borrowing libraries can place their orders in the interlibrary loan system of Libris.

The Members of the EU-LAC Foundation have designated the Library of the Institute of Latin American Studies at Stockholm University, as the National Library Depository for the publications of the EU-LAC Foundation.


As of 2019, the library of the Nordic Latin American Institute is independent from the Stockholm University Library. In practice, this means that the book collections belong to the institute, even though the library still operates under the same system as the Stockholm University library.
