Monday IGV notes by Magnus Mörth, April 8, 2024

1. The applications for the Assistant professor in low-temperature geochemistry are currently being expertly reviewed by professors Per Persson at Lund University and Gesine Mollenhauer, Alfred Wegener Institute for Polar and Marine Biological Research (AWI), Germany. The deadline for the statement is set to May 15.

- 2. The Wallenberg Scholars program aims to provide the country's leading researchers with grants for free research. The Knut and Alice Wallenberg Foundation (KAW) has, after an extensive international evaluation, chosen to fund 118 researchers over five years. Martin Jakobsson, got one of those grants for a project named 'Seabeds are mapped for a better understanding of glaciers'.
- 3. According to the area's prioritisation and dimensioning plan, 1% of the area's UGA funds must be set aside for strategic investments. Richard applied for financial support for the certification process regarding Cat A in marine surveying for the Bachelor's program in marine geosciences 180 credits and recently IGV were granted 540 000 for this certification from the faculty.

The need for competent marine surveyors is great, both in Sweden and internationally. This is largely due to the increased use of the oceans as a resource, with a simultaneous increased environmental focus, and to the green transition. There is also a constant need for sea surveying of our waterways and for questions relating to e.g. our vulnerable infrastructures on the seabeds - we currently have more than 20 underwater cables and 40 marine wind farms under investigation in Swedish waters, plus bridges, tunnels, harbours, etc.

4. Stockholm University has now been notified that we received an approved result after the action report in UKÄ's university review of the quality assurance work for education.

In the first round, the result was approved with reservations. The criticism primarily concerned two areas of assessment where measures were required according to UKÄ's decision, namely regarding student and doctoral student perspectives as well as working life and cooperation.

Ever since this first decision, extremely intensive work has been carried out to remedy the alleged deficiencies.

Regarding student influence, efforts have been made to increase information, communication and support for employees and students, implementation of the digital course evaluation service, a joint degree survey for the entire university and more.
