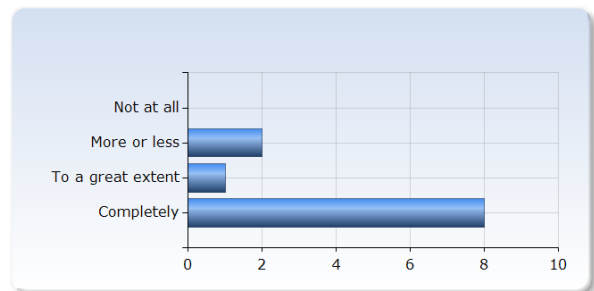

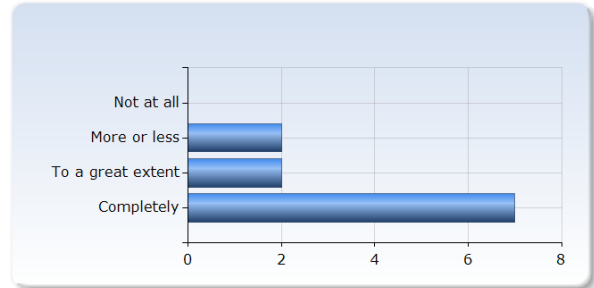
1. Were the aims and expected learning outcomes of the course made clear to you?

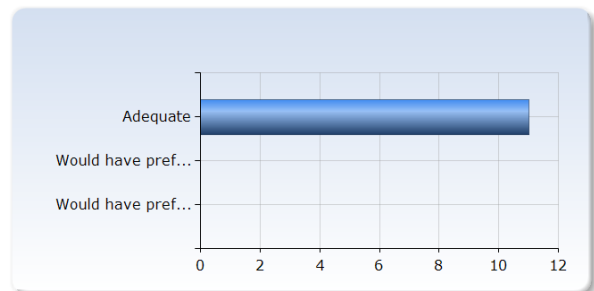
Comment

Yes! It was great!

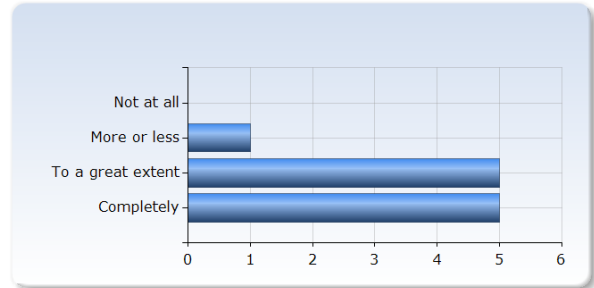

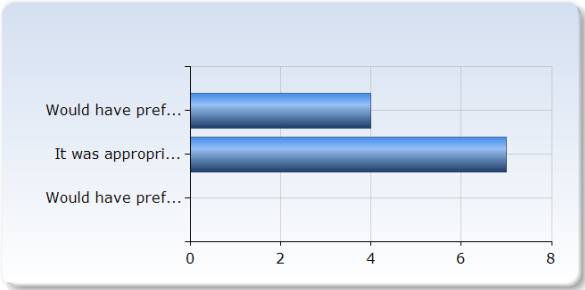
Such a good exercise!

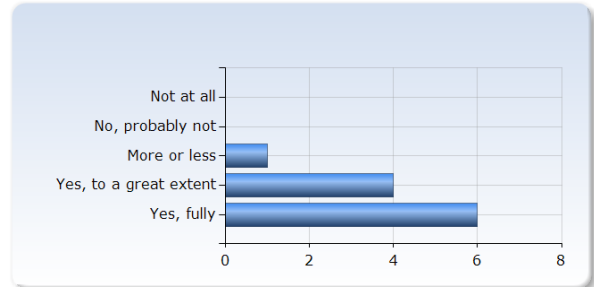
Comment

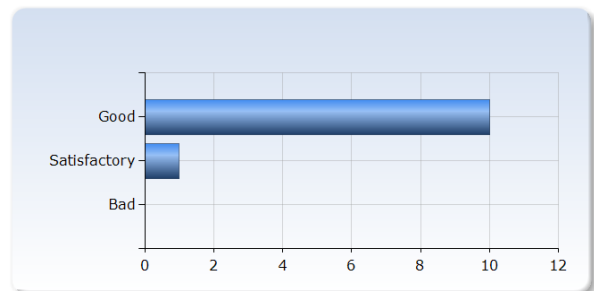

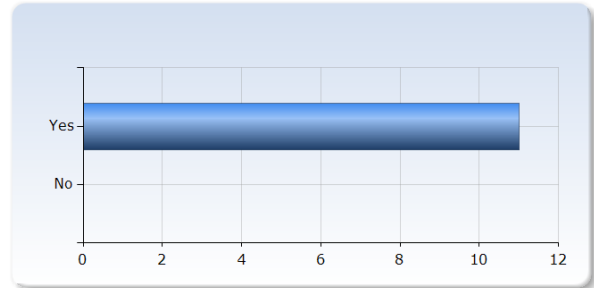

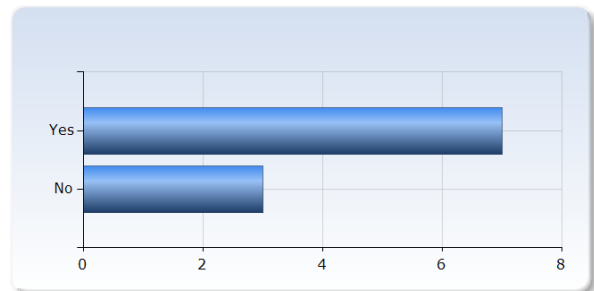
