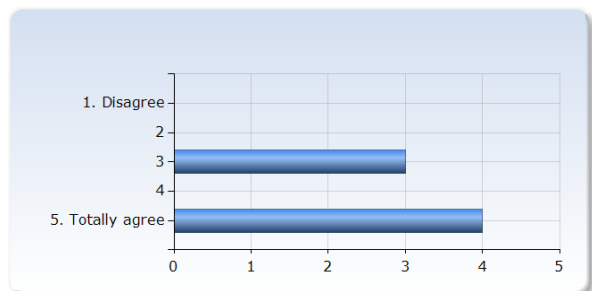

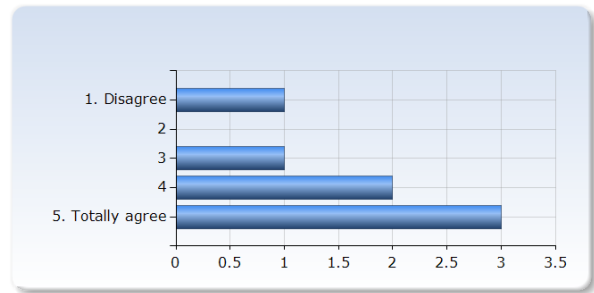

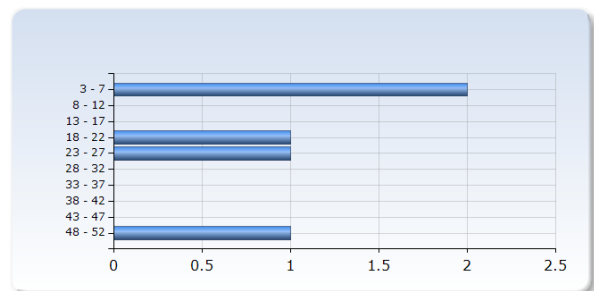

Add the two lectures that were added later on in the course as mandatory lectures

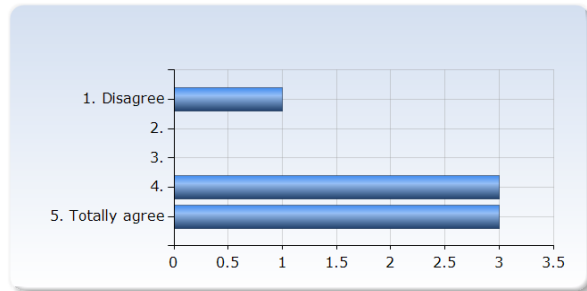

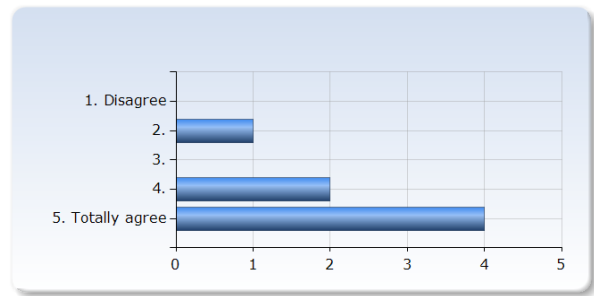

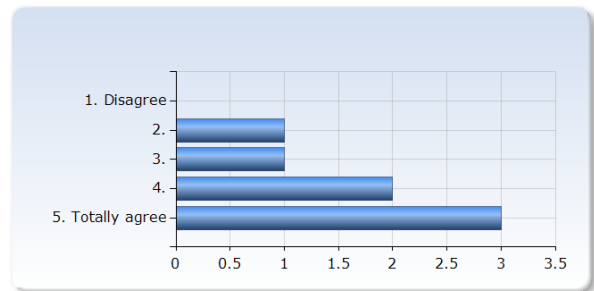

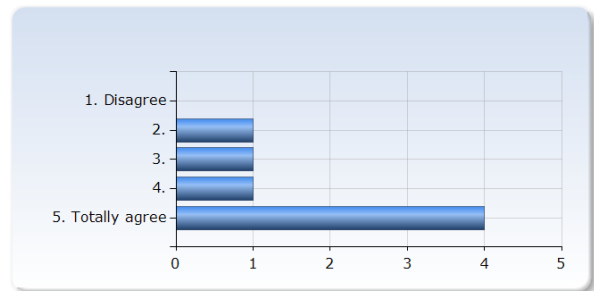

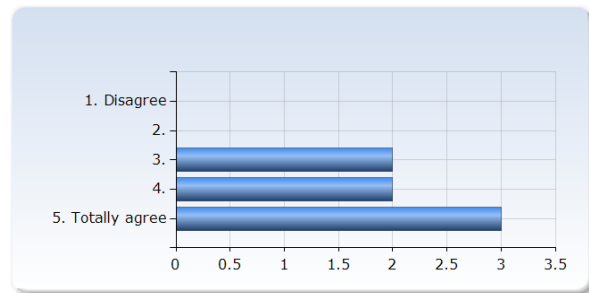

Arguing before a court and an approach to writing were interesting

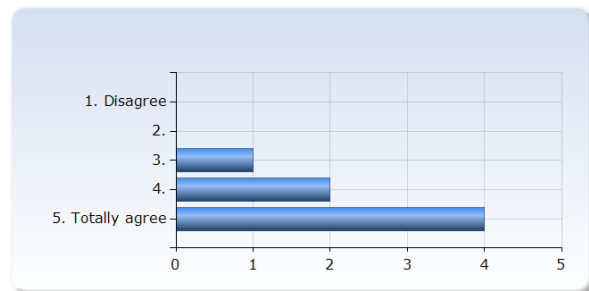

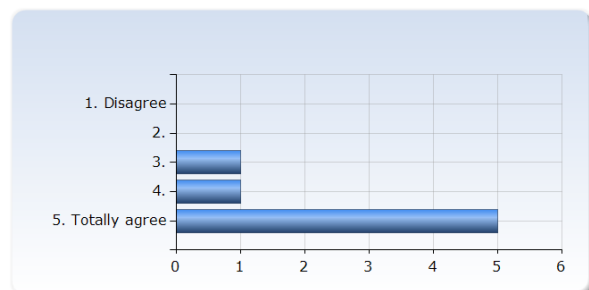

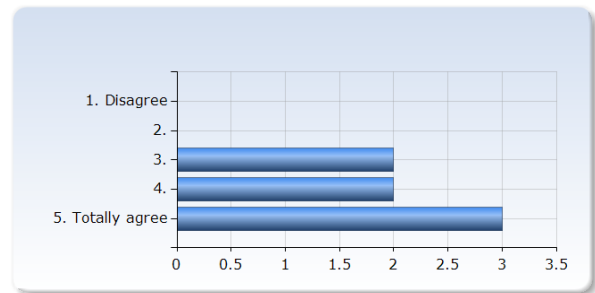

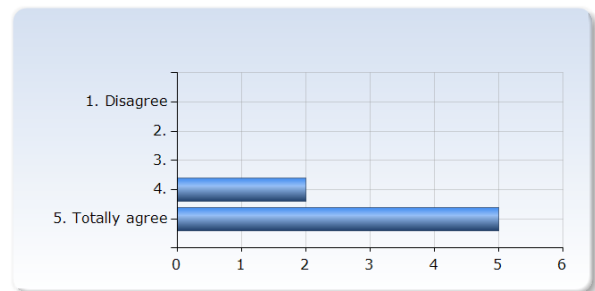

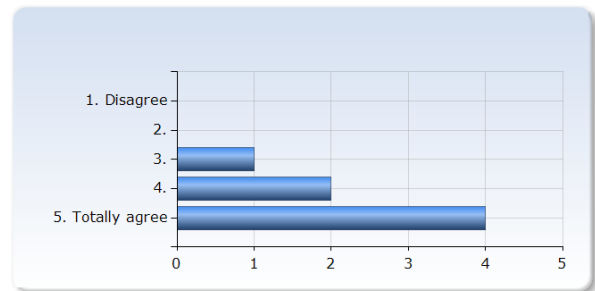

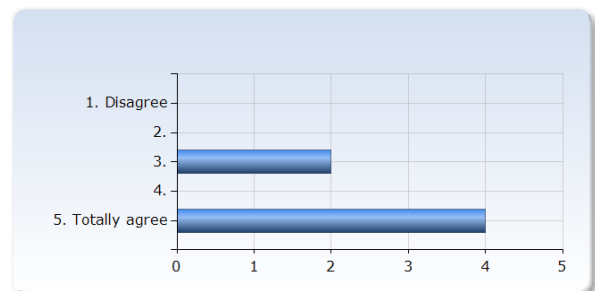

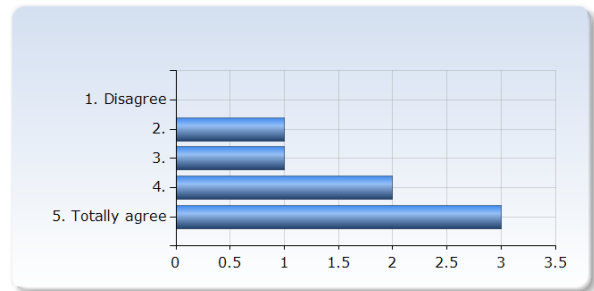
Absolutely excellent all of them! Always open for student questions and very pedagogical, I liked that everyone presented a different style of teaching which was awesome!

I really enjoyed this course. If I had a chance, I would recommend it to my other classmates. Not too much difficult, not too much easy. But it was definitely useful!

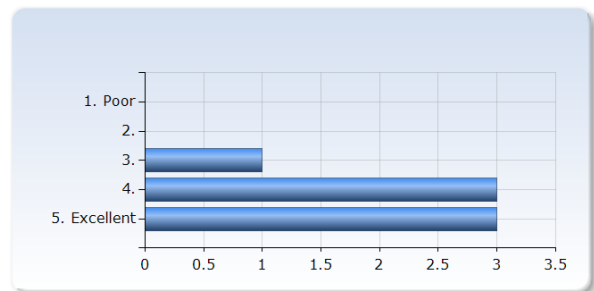

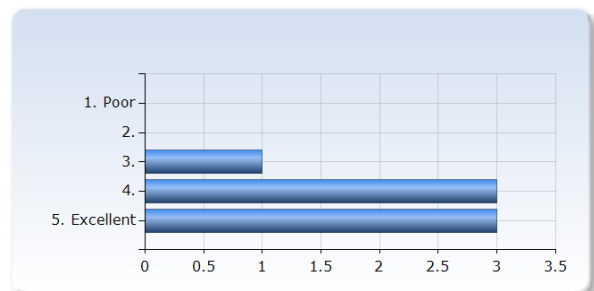

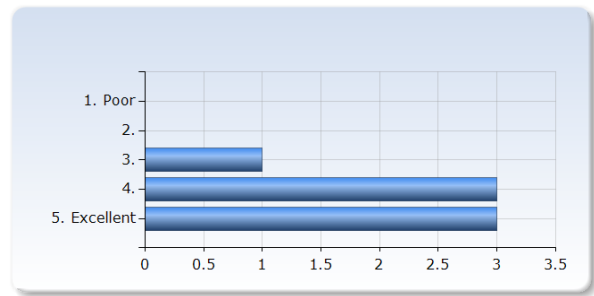

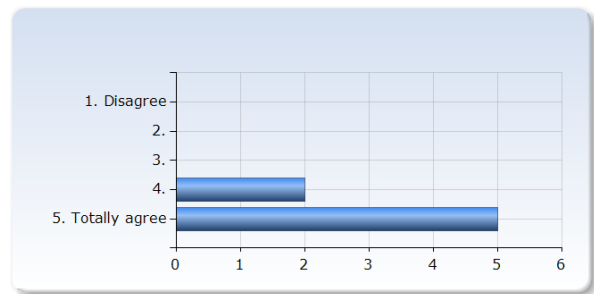

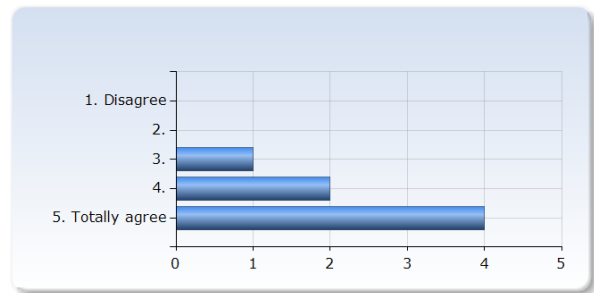
